


1. *The Entrepreneurial Attitude:* Larry's fifth book was a three-way partnership between McGraw-Hill, Junior Achievement and the Farrell Company - written and published to coincide with JA's centennial celebrations in 2019. *The Entrepreneurial Attitude* brings current our decades of research on the world's greatest entrepreneurs – and brings those practice to life through interviews with 70 high-achieving JA alumni across 35



countries such as: AOL founder Steve Case, CNN medical correspondent Sanjay Gupta, British MP David Lammy, Hong Kong biotech entrepreneur Eric Chen, social entrepreneur Fernando Tamayo in Peru, non-profit pioneer HH Shaikha Hessa al-Khalifa in Bahrain, Journalist Adedayo Fashanu in Nigeria and Donna Shalala, former US Secretary of HHS, President of the Clinton Foundation, and now US Congresswoman.

2. "TEA" Goes Global: The book had worldwide distribution with several foreign language editions such as in Romania and Brazil shown below and favorable reviews like the examples below from Brazil and Indonesia.









3. In 2020 - On-Line Entrepreneurship At Laureate Education:



Laureate is the \$2 billion education group which owns the world's largest network of universities, with 875,000 students at over 30 universities worldwide. In early 2019, Larry

had a two day session with executives of Laureate: Darrell Luzzo, (to the right) Senior Vice President for Educational Product, Technology and Innovation, plus two other Laureate Vice Presidents, Barry Sugarman and Wendy Colby. Laureate wanted a full presentation and discussion on converting our entrepreneurship seminars into online programs as part of a new business they were planning. (Of course Darrell is an old friend who first hired us 15 years ago at JA Worldwide.)



By year end, Laureate's plans for starting-up their new venture in the booming micro-credential online training business were finalized. Laureate has assembled a powerful group of partners to provide the online education programs, which they will then market worldwide. The initial four partners are IBM for artificial intelligence, Google for cloud computing, Amazon for digital marketing, and yes, The Farrell Company for entrepreneurship! Starting in January, we will help Laureate editors develop online teaching programs from both our individual and corporate entrepreneurship seminars - and Larry will personally assist in the marketing effort for the first two years. This will be a very different business and a very large project for us. After training six million students over three decades with live instructors, we will enter the 'big leagues' of online education in 2020! Stay tuned...

4. Publicity: The new book continued to receive good publicity around the world. 

The Book Tours Wind Down: The new book was published in early 2018, and Larry has given dozens of keynotes and workshops across North America, Latin America, Asia, Europe and the Middle East promoting the book and supporting JA operations. The day-long event was directed to JA students, JA alumni and the general public. Larry was the keynote speaker and was followed by important JA presentations from Beth as well as Meg Tyquiengo, Chair of the JA Guam Board of Directors. Throughout the day, many more inspiring presentations were delivered by local entrepreneurs and successful JA alumni.



Among the other activities Beth arranged was a long interview on Guam TV with Larry and Board Chair Meg Tyquiengo spreading the JA message. Incredibly, the TV interviewer was a JA alumna herself! 

The initial reason why Andzelika invited Larry to Lithuania, was that she and her Board had decided to translate and publish *The Entrepreneurial Attitude* book in Lithuania, and she wanted Larry to come and kick-off the book promotions.

The main JA event scheduled for the visit was titled: "100 Year JA Centennial: Economic And Entrepreneurship Teachers Conference." Some 100 teachers from different Lithuanian towns, all JA instructors, attended the two day conference to learn about recent research and new teaching methods in the entrepreneurship education field. Larry delivered the conference keynote, covering both the content of The Entrepreneurial Attitude book and the key lessons he has learned from his thirty years of researching and teaching entrepreneurship around the world.

Larry delivered a special presentation at the event on *Creating An Entrepreneurial Economy* which was well received. The young Vice-Minister of the Economy, Marius Skuodis, (to the right) was quite interested in the theme and suggested we stay in touch. Of course we will!





A third big event was Larry's speech at LOGIN, the largest innovation and technology conference in the Baltics. Andzelika very cleverly suggested to the organizers that Larry would be in Lithuania the same week the Conference was running. They responded positively and opened up a general session speaking slot for Larry's one hour Keynote Address. He began his address with a 5 minute overview of JA Worldwide's mission and the *The Entrepreneurial Attitude* book, which he noted would be published soon in Lithuanian.

One evening Larry and Sylvia had a delightful dinner with the JA Lithuania Board of Directors – and even found time for some sight-seeing in Vilnius, one the Europe's oldest and most beautiful cities. 



In its classic cover feature, "The Mystery Of Economic Growth," The Economist said: "Understanding growth is surely the most urgent task in economics. Across the world, poverty remains the single greatest cause of misery; and the surest remedy for poverty is economic growth." But then to underscore the crisis that has plagued the bulk of the world's population throughout history, the article sadly concluded that: "To its shame, economics neglected the study of growth for many years . . . with a few exceptions, the best brains in economics preferred not to focus on the most vital issue of all."

If economists haven't spent much time pondering why some people are rich and others are poor, has anybody? Well yes, I actually did find someone who has thought about it. In fact, he spent most of his life thinking about it. His name is K. T. Li and he was the 20th century's most successful Minister of Economics.

The Five Principles Of The World's Most Successful Minister Of Economics

Republic Of China On Taiwan



K. T. Li, the "father" of Taiwan's economic miracle, is recognized as the architect of the 20th century's greatest economic success story. As his famous quote above implies, he believes common sense, not any arcane economic theory, is the key to economic development. The amazing results in Taiwan say he is right! This small island in the South China Sea has the fifth largest foreign reserves in the world — a stunning feat when you consider Taiwan has zero natural resources to sell and its population is only 24 million. It also has the highest GNP growth (9% per annum) of any country over the past 60 years, and defying all economic theory, it achieved these recordbeating results with practically zero inflation and one of the most equal distributions of income in the industrialized world. In recognition, K. T. Li is the only person to be awarded honorary Chairs in Economics at both Cambridge and Harvard. I had the honor and delight of interviewing him for three hours in Taiwan, which was something akin to taking a crash course on the history of the modern world. Here in K. T. Li's own words, are the principles that created the economic miracle in Taiwan:

"First, we determined that runaway inflation and rural poverty were the main reasons for the rise of Communism on the mainland which forced our retreat to Taiwan. We were determined to avoid those things in Taiwan at all costs. Our overall philosophy for creating national prosperity consists of five broad principles.

♦ Create And Honor The Entrepreneurs

"From the beginning, we believed that entrepreneurs are the backbone of any growing economy and the government should do everything in its power to help them succeed. We knew that if we helped create one entrepreneur, he could create fifty more jobs. This was our principal policy!

♦ Government's Job Is To Make The People Rich

"The policy has always been that everyone: the farmers, the domestic businessmen, the exporters, should all become prosperous. The government's job was to do everything in our power to help them. Fighting inflation was also a big part of the policy. We never took the easy way on money. We never printed money we didn't have – never.

♦ Align The Job/Baby Ratio

"This is more important than any economic theory. People growth and economic growth have to be in step. Population control is controversial everywhere, but we understood the job/baby ratio had to be for every two babies born, we had to create one new job. Look around. Whether it's Catholic, Muslim, Buddhist, where you find too many people, you find poverty.

♦ Big Investments In Small Businesses

"We favored big investments in small companies because they will create 90% of the new jobs. The government provided or arranged the venture capital to create new enterprises. It worked wonders for our economy!

♦ Educate Youth In Future Products/Services

"It's obvious, your schools must educate the young people in how to make and sell the new products and services of the world."

The Entrepreneurial Basics Applied To The Entire Economy

Let's take a closer look at K. T. Li's "principle policy" – Create And Honor The Entrepreneurs. How does an entire country do that? How can governments create more entrepreneurial economies? Adapting and instilling the entrepreneurial basics across the economic, educational and political fabric of the country would be a great place to start. As described in The Entrepreneurial Attitude book, those four basics are: Sense of Mission, Customer/Product Vision, High-Speed Innovation and Self-Inspired Behavior. If instilling these entrepreneurial basics throughout an entire country sounds complicated, the fundamental questions to ask aren't. Let's examine them one by one:

♦ A National Sense Of Mission

Does your country/region have a shared national mission? Is your economic strategy 'smart or stupid?' Is everyone committed? Does your culture support your strategy or block it? Are your national values maximizing your global competitive position? How do you rate on this characteristic?

♦ Customer/Product Competitiveness

Does your country/region produce superior goods and services at lower costs than your best competitors? Do you have the highest skilled and hardest working labor force in the world? These qualities are determining the competitive position of your country! What is your global rating here?

♦ A National Urgency To Improve

Do you have a national/regional sense of urgency about solving old problems and exploring new frontiers? Is there an attitude across the work force of 'what can I do today better than yesterday?' Do you encourage and reward innovative action? What are you doing to avoid complacency and bureaucracy? Where do you rank globally on this?

♦ A Nation Of Self-Inspired People

What are you, as a society, really inspired about? Are your people demonstrating higher performance and higher commitment than competitor nations? Are the positive and negative consequences in place to make all this happen? How do you compare globally on this point?

Government economic development officials have become true believers that fostering entrepreneurship is a political and economic winner. Average start-up cost: \$15,000 A year on welfare: \$25,000 A college scholarship: \$50,000 A year in prison: \$75,000

It's really a no-brainer for government economic development chiefs when they realize they can help five citizens start job-creating businesses for the cost of keeping one criminal in prison one year!

And this is the point. We may all need to expand our thinking about the full power and promise of the entrepreneurial spirit. It isn't just a nice thing for a few characters like Richard Branson or Elon Musk or Oprah Winfrey to live out their business dreams. It's much more than that. It's the surest and fastest path out of poverty for poor people everywhere, and it's the most powerful economic development tool ever invented for every country of the world. Hopefully, armed with this expanded vision of the power and promise of the entrepreneurial attitude, we can begin to provide some answers to "the most important question in economics . . . why are some countries richer than others?"
